
Preparing Children for School


At least three times a year child-level assessment data is aggregated and analyzed. Pace has established 12 school readiness goals based on input from kindergarten teachers, parents, and Health Services Advisory committee members. Learning is accomplished through large and small group activities using play and hands on experience. The following data represents kindergarten-bound children's progress in achieving school readiness goals. Early Head Start (EHS) data reflects children transitioning to Head Start or other pre-schools. Activities are planned and *individualized* based on children's *developmental levels*.

Enrollment Data

Funded Enrollment = 294 Head Start: 69 Early Head Start and 32 Early Head Start Expansion Children. Our Early Head Start Expansion grant funds our center based EHS slots.



Our average monthly funded enrollment was maintained at 94%. We requested and received an enrollment reduction; although despite the reduction, we could not maintain full enrollment due to an ongoing staffing shortage.

Disabilities

We are committed to serving families of children with disabilities. In fact, at least 10% of our funded enrollment must be children with IEPs (Individual Education Plan) or IFSPs (Individual Family Support Plan).

Health- Medical and Dental Exams

Head Start strives to help families keep their children on schedule for physical and dental examinations. Health information is provided through lessons, family events, and newsletters. Dental kits, were sent home regularly with our children, that included toothbrushes and toothpaste. We also assist families in obtaining health insurance and medical/dental providers. By the end of the school year a majority of our children had health insurance- Head Start at 99% while Early Head Start and Early Head Start Expansion families were both at 100%.

56 % of the Head Start children received preventative dental care with 87% getting continuous accessible dental care.

Pace Community Action Agency, Inc. is a private not-for-profit organization established to provide support services to improve the community and encourage selfreliance. Services are provided without regard to race, age, color, religion, sex, disability, national origin, ancestry, familial status, or status as a veteran.

Family Engagement and Community Assessment

We continuously receive/review data. Our recently updated community assessment revealed that we are in a rural, low-income area, and our community is relatively unchanging. Our demographic information shows that we are predominantly Caucasian and English speaking.

We understand that family engagement is key to a child's success. After some of the challenges of COVID-19, we began having parents volunteer in our classrooms again. This not only helped us, but gave the parents an opportunity to learn new skills for the workforce. In addition, we referred families to community resources to increase their education.

Our staff actively support families to achieve goals through the family partnership process. Families met 393 goals with our staff and 414 referrals were given. 52 of our families gained employment during the school year!


